Notes to Applicants

- 1. According to the Government Rent and Premium (Apportionment) Ordinance (Cap. 125), application must be made by the registered owner(s).
- 2. According to the Government Rent and Premium (Apportionment) Ordinance (Cap. 125), the Director of Lands shall, in making apportionment on sections and on relevant interest, add to the determined Government rent/premium the following sum:

Apportionment of Government rent

- such sum as may be necessary to make the determined Government rent an even number of dollars; and
- a further sum of \$2.

Apportionment of Premium

- such sum as may be necessary to make the determined premium an even number of dollars;
- a further sum of \$10.

After apportionment, the amount of determined Government rent/premium of the premises may be greater than the existing Government rent/premium.

- 3. With effect from the publication in the Government Gazette of a notice of the determined Government rent/premium, the owner(s) shall pay all arrears of the Government rent/premium, if any, and the future Government rent/premium as so determined.
- 4. Depending on the complexity of each case, the processing time to complete normal apportionment of Government rent/premium may take about 5 to 6 months.

Personal Data (Privacy) Ordinance (Cap. 486)

- Each applicant has the right of access to and correction of the personal data including obtaining a copy of the application form upon payment of the prescribed copying fee.
