RESUMPTION OF UNDERGROUND STRATA OF LAND

The above scheme has been authorized by the Chief Executive in Council and such authorization was gazetted in Government Notice No. 1835 published on 20 March 2009 and 27 March 2009.

This notice was affixed on or near the land on 8 January 2010.

The Deputy Director of Lands/Specialist has under section 18(1) of the Ordinance specified a period of notice of ONE MONTH from the date upon which this notice was affixed on or near the said land and upon expiry of that period, the underground strata in respect of the land by virtue of section 18(2) of the Ordinance revert to the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the scheme.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for the Transport and Housing before the expiration of one year from the date of resumption.
