RESUMPTION OF UNDERGROUND STRATA OF LAND

TAKE NOTICE that under powers delegated by the Chief Executive, the Deputy Director of Lands/Specialist has made an order under section 16 of the Railways Ordinance (Chapter 519) (hereinafter referred to as 'the Ordinance') directing that the underground strata in respect of the land more particularly described in the first column below and between the levels specified in the second column below:—

as shown coloured blue stippled black on Underground Strata Resumption Plan No. RDM1170 annexed to the said order, which land was described in the scheme referred to in Government Notice No. 6865 published on 26 October 2007 and 2 November 2007, and as amended by Government Notice No. 6294 published on 12 September 2008 and 19 September 2008, and as corrected by Government Notice No. 135 published on 9 January 2009 and 16 January 2009, and as modified by Government Notice No. 1835 published on 20 March 2009 and 27 March 2009 shall be resumed.

The above scheme has been authorized by the Chief Executive in Council and such authorization was gazetted in Government Notice No. 1835 published on 20 March 2009 and 27 March 2009.

This notice was affixed on or near the said land on 30 July 2010.

The Deputy Director of Lands/Specialist has under section 18(1) of the Ordinance specified a period of notice of ONE MONTH from the date upon which this notice was affixed on or near the said land and upon expiry of that period, the underground strata in respect of the said land shall by virtue of section 18(2) of the Ordinance be reverted to the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the scheme.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing before the expiration of one year from the date of resumption.
