## CREATION OF RIGHTS OF TEMPORARY OCCUPATION OF LAND

TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 20(1) of the Railways Ordinance (Chapter 519) (hereinafter referred to as 'the Ordinance') directing that the rights of temporary occupation of the land as shown coloured purple stippled black, purple stippled black hatched blue, purple stippled black cross-hatched blue and purple hatched black on Creation of Rights of Temporary Occupation of Land Plan No. RDM 1001 (Sheets 1 to 4) ('the Plan') annexed to the said order, and more particularly described in the first column below and for the periods specified in the second column below:—

The Deputy Director/Specialist, Lands Department has under section 20(3) of the Ordinance further directed that subject to the serving of any notice required to be given under section 20(5) of the Ordinance, Government officers, any persons authorized by the Government of the Hong Kong Special Administrative Region, and his or their workmen, servants, agents and contractors are hereby authorized to enter upon the said land and any buildings thereon for the purposes of carrying out any operations or installing, maintaining or removing any structures or apparatus for the purposes of the said order.
