CREATION OF RIGHTS OF TEMPORARY OCCUPATION OF
UNDERGROUND STRATA OF LAND

CORRIGENDUM

It is hereby notified that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director of Lands/Specialist has amended ('the Amended Order') the order made by him under section 20(1) of the Railways Ordinance (Chapter 519) on 16th day of July 2010 for creation of the rights of temporary occupation of underground strata of land for the purposes of or incidental to the scheme referred to in Government Notice No. 6865 published on 26 October 2007 and 2 November 2007, and as amended by Government Notice No. 6294 published on 12 September 2008 and 19 September 2008, and as corrected by Government Notice No. 135 published on 9 January 2009 and 16 January 2009, and as modified by Government Notice No. 1835 published on 20 March 2009 and 27 March 2009 and authorized by the Chief Executive in Council which authorization was gazetted in Government Notice No. 1835 published on 20 March 2009 and 27 March 2009. Accordingly, Government Notice No. 4785 dated 30th July 2010 ('the said Notice') published in the Government of the Hong Kong Special Administrative Region Gazette No. 30 of 30th July 2010 is hereby amended as follows:—

- (a) The description of the land as 'The Remaining Portion of Section B of Marine Lot No. 200 (Portion), Subsection 1 of Section B of Marine Lot No. 200 (Portion) and Section C of Marine Lot No. 200 (Portion)' in the first column of the table of the said Notice shall be deemed to have been amended to 'The Remaining Portion of Section B of Marine Lot No. 200 (Portion), Subsection 2 of Section B of Marine Lot No. 200 (Portion), Section A of Subsection 1 of Section B of Marine Lot No. 200 (Portion), The Remaining Portion of Subsection 1 of Section B of Marine Lot No. 200 (Portion), Subsection 1 of Section C of Marine Lot No. 200 (Portion) and The Remaining Portion of Section C of Marine Lot No. 200 (Portion)'; and
- (b) 'The Creation of Rights of Temporary Occupation of Underground Strata Plan No. RDM1169' as mentioned in the said Notice shall be deemed to have been amended and replaced by 'the Creation of Rights of Temporary Occupation of Underground Strata Plan No. RDM1169a' annexed to the Amended Order.
