Points to Note

1. The applicant may be requested by the Lands Department to employ an Authorized Land Surveyor or Registered Professional Surveyor to determine the lot boundaries or to resolve any boundary problem. Alternatively, the applicant may reduce the building area of the proposed house to avoid any encroachment on the adjoining private / Government land, or choose to solve the problem by way of land exchange.
2. The applicant should note that the rebuilding works may affect the adjoining house(s). As such, the applicant should ensure that such adjoining structures will not be affected during the demolition of the old house and the rebuilding of the new house. The applicant shall also bear full responsibility for the demolition and construction works.
3. The applicant should note that if the rebuilding warrants any modification of lease conditions, he / she may have to pay administrative fees and / or premium to the Government.

Supplementary Notes

Purpose of collecting personal data

1. The personal data provided in this application form will be used by the Lands Department for processing this application for rebuilding a village house in the New Territories.
2. The provision of data by means of this application form is voluntary. If you do not provide sufficient information, the Lands Department may not be able to process your application.

Classes of Transferees

3. The personal data provided in this application form may be disclosed and transferred to other Government bureaux / departments and the Land Registry to determine your eligibility for the application as landowner(s) or the approval conditions for your application.

Access to Personal Data

4. You have the right of access to and correction of your personal data under Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data provided by this application form.

Other Points to Note

1. If you are unable to provide any document mentioned in the application form (see “Documents attached”), you must inform us of the reasons for us to proceed further with the processing of your application.

2. We may not be able to process your application in the event of the following:
 - (i) The applicant is not the registered owner of the lot(s).
 - (ii) The Lot(s) is / are owned by co-owners, and the application is not submitted by all co-owners of the lot.
 - (iii) The location of the proposed house within the lot(s) has not been indicated.
 - (iv) Building of houses is not permitted under the lease in respect of the lot(s) applied for.
 - (v) The lot(s) under application falls within a resumption / clearance limit.
 - (vi) The applicant fails to meet the requirements, including proving the indigenous villager status, for modification of lease conditions at standard premium.
 - (vii) The applicant fails to address / resolve some relevant matters including but not limited to the appropriate matters such as the submission of a geotechnical report.
 - (viii) The application does not comply with the relevant provisions of the Development Permission Area Plan or Outline Zoning Plan and a planning permission has not been obtained.
