## Measures to Avoid Encroachment onto Government Land

When owners (Grantees) proceed with development of their lots, there is the possibility that the proposed development may be contiguous with the lot boundary. When such situation happens there may be increased chances that the new development may unintentionally encroach onto the adjoining Government land.

- 2. In order to avoid any completed development extending beyond the boundary of the private lot, hence, onto Government land, Government expects Grantees throughout the development period will, through the Authorized Person (AP)<sup>1</sup> they have appointed, ensure that their developments will not encroach onto Government land or at least when encroachment is found, it will be rectified at the earliest possible time or otherwise unavoidable delay may be caused to their applications for the issue of Certificate of Compliance (C of C).
- 3. In preparing the general building plans (GBP) for approval by Buildings Department and Lands Department, the AP should ensure that the proposed development will not encroach onto Government land<sup>(2)</sup>. This may be done by providing in the GBP a block plan of the proposed development together with a table showing the lot boundary co-ordinates which are in line with the co-ordinates shown on the sale/grant plan provided or agreed by the District Survey Office.
- 4. Grantees are also advised, in drawing up tender documents for construction works, to ensure that the tender documents will specify that the contractor's setting out work shall be checked by an independent competent person, prior to the commencement of any construction work on site, which is in close proximity to the lot boundary. Thereafter the AP is required to confirm to the District Lands Office concerned that, having examined the report given to him by the independent/competent person, he believes that the construction work to be carried out will not encroach onto any adjoining Government land<sup>(2)</sup>.
- 5. To facilitate the processing of applications for the issue of C of C upon completion of the development, the AP is required to submit to the District Lands Office concerned, a further confirmation certifying that the development is built in

accordance with the approved building plans and does not encroach onto Government land. The AP may, if he so wishes, jointly sign the letter of confirmation with the contractor and the independent competent person that he may have appointed.

6. If any encroachment onto Government land<sup>(2)</sup> is found, I may require appropriate reinstatement of the encroached land including demolition of structures erected thereon. I may also exercise, upon application by the Grantee, the power under the General Condition of the lease to grant the encroached land as an extension subject to any conditions including payment of additional premium. However, Grantees should note that this is a discretionary power which I may elect not to exercise.
