APPLICATION PROCEDURES

- (a) This application form (SMF-0051) is for the reinstatement of name after removal from the register of authorized land surveyors ("ALS") within 3 years of discontinuation of the ALS registration under section 15(1)(b) and/or removal of name from the ALS register under sections 15(2)(a), (b) of the Land Survey Ordinance (Cap. 473). For any applicant who has discontinued his/her registration and/or with his/her name removed from the register for more than 3 years, please use another form SMF-0014 to re-apply for registration as an authorized land surveyor.
- (b) Notwithstanding paragraph (a) above, the Land Surveyors Registration Committee may refuse an application for reinstatement of name of a person whose name was removed from the register under section 15(2)(a) of the Ordinance and require him to reapply for registration.
- (c) When you submit your application, please also produce:
- original of your H.K.I.D. or a passport or travel document;
 - original and copy of documentary evidence to substantiate any additional professional membership that has never been submitted to the Committee;
 - original and copy of the latest receipt for the annual subscription of the professional institute; and
 - a cheque (made payable to "The Government of the Hong Kong Special Administrative Region" and crossed) for payment of the prescribed fee in the Land Survey (Fees) Regulation (Cap. 473 sub. leg. A) for the reinstatement of name in the register.
