

LAND ACQUISITION (POSSESSORY TITLE) ORDINANCE (Chapter 130)

ACQUISITION OF LAND FOR
THE IMPLEMENTATION OF
LIANTANG/HEUNG YUEN WAI BOUNDARY CONTROL
POINT AND ASSOCIATED WORKS PROJECT*(Notice under section 4)*

To every person on whom notice shall be served under section 4(1)(a) of the Land Acquisition (Possessory Title) Ordinance in respect of any of the several areas of land situate in the North District and the Tai Po District comprising a total area of approximately 874.8 square metres and respectively shown coloured red on Plan No. DNM2595a, such areas of land being hereinafter separately and together referred to as 'the land'.

TAKE NOTICE that the Chief Executive in Council decided that the acquisition of the land is required for a public purpose, the Director of Lands acting under section 3(1) of the Land Acquisition (Possessory Title) Ordinance on the 10th day of September 2012 made an acquisition order for the acquisition of the land, which order together with the said Plan No. DNM2595a described above may be inspected free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice was affixed on the land on 13 September 2012.

IT IS HEREBY DECLARED that upon the expiration of one month from the day of the affixing of the notice on the land, the land shall by virtue of section 5 of the Land Acquisition (Possessory Title) Ordinance vest in the Government of the Hong Kong Special Administrative Region and that every interest, right or easement of any person in or over the land shall be extinguished.

Every person making a claim of ownership to the land or to any part thereof or claiming any interest, right or easement in or over it, shall in accordance with section 6(1) of the Land Acquisition (Possessory Title) Ordinance submit to the Director of Lands a written notice of his claim together with such evidence as he may possess to substantiate it before the date of vesting as mentioned above or within such further period, if any, as the Director of Lands may permit.
